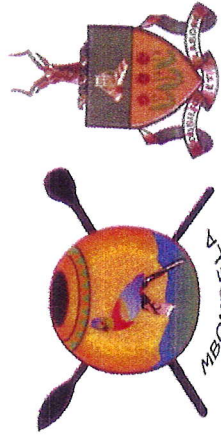

Supply chain management recommends that:


- (a) The quorum for Bid Evaluation Committee shall be formed by a fifty plus one or a total of five Bid Committee members.
