NOTICE TO DEVELOP A MUNICIPAL SPATIAL DEVELOPMENT FRAMEWORK (CITY OF MBOMBELA)

Notice is hereby given, in terms of section 28(3) of the Municipal Systems Act, 2000 (Act 32 of 2000) as well as Section 6 (b) of the Mbombela By-Law on Spatial Planning and Land use management (2015) that the City of Mbombela intends to develop its Municipal Spatial Development Framework (MSDF).

A Municipal Spatial Development Framework (MSDF) is a long-term forward planning document which spatially indicates the long-term growth and development path of a municipality. It co-ordinates the spatial implications of all strategic sector plans of a municipality. A MSDF is also one of the core components of a municipal IDP and gives physical effect to the vision, goals and objectives of the municipal Integrated Development Plan (IDP). Once completed, the MSDF will be approved in terms of the Municipal Systems Act, 2000 (Act 32 of 2000) and will serve as a guide to decision making in development and land use planning.

The draft MSDF will subsequently be advertised for public input during a public participation process. The revised final draft MSDF will be submitted to Council for adoption. Should the adopted final draft MSDF be materially different from the initial version that was out for comment, it will be re-advertised. Once re-advertised and subsequently adopted by Council, a notice will be published in the Provincial Gazette and media to inform the public of the adopted MSDF.

In essence the process to be followed when compiling the MSDF for the City of Mbombela will comprise of the following Phases: Project Inception, Phase 1: Start Up and Initiation Report, Phase 2: Issues and Vision, Phase 3: Spatial Analysis, Phase 4: Draft SDF Document, Phase 5: Achieving Support for draft SDF, Phase 6: Finalisation and Approval, Phase 7: Preparing Implementation.
